1. The rates(s) quoted should be strictly for free delivery and installation at the various places of Tourism Department at Dadra & Nagar Haveli and the rates quoted should be valid for a period of six months.
2. The rates quoted should be inclusive all Taxes.
3. **The single rate of item should be quoted with the brand name, manufacturer, otherwise tender will be rejected.**
4. Rates quoted for items other than the required Specifications shall not be considered.
5. The decision of the Tender Inviting Officer for acceptance / rejection, if any articles supplied including the decision for equivalent specifications, standard and quality etc. of articles shall be final.
6. The bidder has to submit the mandatory documents as under:-
  - a. Copy of Tender Fee in form of Demand Draft (DD)/Banker's Cheque.
  - b. Copy of EMD in form of Demand Draft (DD)/Fixed Deposit Receipt (FDR).
  - c. Copy of last year's Income Tax Return.
