### TERMS AND CONDITIONS

1. Rates for the above items should be inclusive of all taxes (GST) with transportation, labour charges, utensils, disposables, serving counters, cooking charges, Water Charges etc.
2. Good Quality ingredients/materials shall be used for cooking.
3. The food will be prepared and provided at venue of Dr. APJ Abdul Kalam Govt. College under supervision of Food Management Committee of the college.
4. Quotation application duly completed in all respects should be accompanied by Demand Draft or FDR for Rs. 5000/- (Rupees Five Thousand only) as Earnest Money Deposit in favour of the “**DR. APJ ABDUL KALAM GOVT. COLLEGE**” payable at Silvassa. The EMD submitted in any form other than mentioned above will not be accepted. Quotation received without EMD will be summarily rejected.
5. The quotation should reach to the office of the undersigned upto 4.00pm on **11/02/2019**. Quotation received after due date and time shall not be entertained.
6. Sealed envelope should be super-scribed word “**Quotation for Food items**”.
7. Inferior quality foods, unhygienic or expired shall be out-rightly rejected. The firms shall replace the same, failing which payment may be withheld and made after full satisfaction of the representative of the college. Bidders are expected to supply good/standard quality materials.
8. The menu of item can be changed/replaced with mutual agreement.
9. Food servers shall be in sufficient numbers to serve food at 05 counters.
10. The bidders must have FSSAI certificate/ license for providing catering service in UT of Dadra and Nagar Haveli.
11. This is a Quotation notice. The supplier should quote rates, as per **Annexure-A** attached herewith the notice, on their own letter heads OR on plain paper duly rubber stamped and signed.
12. The rates should be valid for 06 months initially from the date of quotation and extendable further, if mutually agreed.
