Agriculture Farm, Dokmardi, Silvassa so as to reach the office of undersigned on or before 06/06/2018 at 15.00 hours by RPAD/Courier/tender box kept in the office.

The tender in prescribed form accompanied by EMD of Rs.12000/- (Rupees Twelve Thousand only) in the form of FDR/DD of any Nationalized Bank/ Scheduled Bank should reach the undersigned by RPAD/ Courier or to be deposited in the tender box kept in the office of the undersigned on or before 15.00 hours upto **06/06/2018.** The envelope should be super scribed with words as "Tender for Purchase and Replacement of Green Net and White Net for Net house and Poly house at Govt. Agriculture Farm, Dokmardi, Silvassa". The tenders will be opened on the same day, if possible at 16.00 hours in the presence of intending tenderers who may be present at that time.

Terms and Condition for Purchase and Replacement of Green Net and White Net for Net house and Poly house with installation and accessories at Government Agriculture Farm, Dokmardi, Silvassa.

1. The rates quoted should be strictly for free delivery at FOR, Silvassa and will be valid and operative for one year.
2. The rates quoted should be inclusive of all taxes (GST).
3. No extra charge for packing, forwarding or insurance will be paid on the rates quoted.
4. The rates should be quoted only for the items specified in the list requirements and should be for the items of given specifications.
5. The decision of the Tender Inviting Officer for acceptance or rejection of any articles supplied including the decision for equivalent specifications, standard and quality etc. of articles shall be final.
6. The tender should enclose Earnest Money Deposit of **Rs.12000/-** (Rupees Twelve Thousand only) drawn in form of F.D.R./DD from of any Nationalized Bank /Scheduled Bank payable at Silvassa drawn in favour of the Deputy Director of Agriculture. Tenders received without Earnest Money will not be accepted and summarily be rejected.
7. The amount of earnest money deposited by the successful bidder will be adjusted against the amount of security deposit or will be refunded as may be convenient.
8. The amount of Earnest Money Deposit paid by the tenderer whose tenders are not accepted will be refunded to them. **No E.M.D.** or Security Deposit will be refunded to the successful bidder whose tender accepted for supply the materials before expiry of time limit prescribed by the tender inviting officer.
9. In case failure to replace the accepted and rejected articles from supplies made, as mentioned in the conditions, the loss undergone by the Government will be

recovered from the Earnest Money Deposit or from the payment due of bill of the supplier to the extent required.

10. In case of failure to supply and replacement of Green Net and White Net as per Terms and condition & stipulated time, the same will be obtained if required from the tenderer who offered next higher rates or from any other sources as may be decided by the Tender Inviting Officer & the loss to the Government on account of such purchase shall be recovered from the earnest money deposit.
11. The tenders will be opened in the presence of tenderers or their representatives if present in the office of the Tender Inviting Officer.
12. The right to accept or reject without assigning any reasons any or all tender in part or whole is reserved with the Tender Inviting Officer and his decision (S) on all matters or in part will be final and binding to all.
13. The tender received which do not confirm with the terms and condition of this office will be summarily rejected.
14. If the supplier whose tender is accepted fails to execute the work within stipulated time, the **E.M.D** of such supplier will stand forfeited to the Government.
15. After receipt of the work order, the Green Net and White Net for Net house and Poly house with installation and accessories at Government Agriculture Farm, Dokmardi, Silvassa will be completed within 21 days failing which action will be taken as per condition No. 10.
17. If possible, the limited tender will be opened on the same day after 16.00 hrs in the presence of supplier who may be present at the time of opening of limited tender.
