ORDER
(u/s 144 Cr.PC)

WHEREAS, for the infrastructural development of the District of Dadra & Nagar Haveli, the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu has undertaken many developmental projects such as Ring Road, Fly Overs, Sky Walk etc.;

AND WHEREAS, a similar project of flyover has been undertaken at Ring Road junction 'A' on Silvassa Naroli Road;

AND WHEREAS, due to the continuous flow of heavy vehicular traffic on the said flyover project from Shahid Chowk to Athal Bridge and from Jas Exotica to Ring Road Junction 'A' on Silvassa Naroli Road, the developmental work is getting hindered thereby putting the said project behind the Schedule;

AND WHEREAS, also due to the heavy vehicular traffic near the said flyover and monsoon rains, the use of the road towards the said flyover has become prone to accidents which could easily endanger the lives of the people using it;


THEREFORE, in view of above and in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order as under:

1. The use of the Road from Jas Exotica to Ring Road Junction 'A' on Silvassa Naroli Road shall be strictly prohibited;
2. The agency should deploy sufficient number of Staffs / Marshals to control the entry / exit of traffic of the nearby residents / Yatri Niwas.
3. The agency should provide sufficient quantity of blinkers and reflectors for the barricades and road closures.
4. The agency should provide necessary signage at Shahid Chowk / Ring Road Junction A for diversion of traffic.
5. The agency should provide necessary access to the people whose residences fall within the stretch of road that has been closed.
6. Any person found in contravention of this order shall be punishable under section 188 of Indian Penal Code.

In case of violation of above, violating vehicles will be impounded and shall be released on payment of prescribed penalty.

This order shall come into force immediately from the date of issue and shall be effective until 15 days from issuance of this Order.

As the Order cannot be served individually, the Order is put in the public domain for information and necessary action.
