Terms and Conditions for Hiring of Refrigerated Van (Preferably Mahindra Pickup) along with Driver and Helper collection, transportation and distribution of milk in Dadra & Nagar Haveli.

Instruction of Transporter :

1. The rate should be quoted in the prescribed form given by the Corporation; the rate should be inclusive of all taxes and should be valid up to two years from the date of tenderization.
2. All Taxes / Duties / Royalties Charges etc payable in respect of the vehicle to be hired shall be paid by the vehicle supplier.
3. The tenderer should enclose an amount of ₹500/- as Tender Fee (Non-Refundable) in form of Demand Draft and ₹25000/- as Earnest Money Deposit (EMD in form of FDR of any Nationalized or Scheduled Commercial Bank payable at Silvassa in favour of DNH DD SCST OBC & Mino. FDC Ltd along with tender. Tender received without Tender fee and EMD shall be summarily rejected.
4. The tender should be neatly typed or hand written only on letter head. No overwriting, correction or erasures will be considered.
5. All bills should be in TRIPLICATE and should invariably mention the number and date of supply order.
6. The tenders shall be submitted in two bid system, each of which is to be submitted in separate envelope. The first envelope should contain Technical Bid and super scribing on the envelop as "Sealed Cover No.1 - Technical Bid - Hiring of Refrigerated Van". The EMD and Tender fees should be enclosed with TECHNICAL BID only. The second envelope should contain FINANCIAL BID for Hiring of Refrigerated Van.
7. The offer will be opened by the Committee in the chamber of undersigned in the presence of the tenderers or their representatives if possible, on the same day during working hours.
8. The right to accept or reject any or all tenders without assigning any reason are reserved with the undersigned and his decision(s) on all matters relating to acceptance or rejection of the tenders as a whole or in part shall be final and binding to all.

Conditions of Contract:

1. The rate quoted should be inclusive of all taxes including service charge and no extra charges will be paid and the rate should be valid for the period of two years from the date of tenderization.
2. The Vehicle must have valid Registration, PUC and Insurance Certificates and should be in good condition preferably not registered earlier then 01.01.2020.
3. The rates quoted must be inclusive of all taxes, fuel charges, oil, wages of Driver & Helper and other maintenance Charges.
4. The rates may be quoted on per litre basis.
5. On acceptance of rate in all respect, the vehicle should be handed over to the department within 05 days from the date of receipt o the work order.
