The team No. 1 & 2 shall be headed by Shri Suresh Patel, Assistant Engineer-I/ASW(SE), SMC (Mob. 9924137165), Team No. 3 & 4 shall be headed by Shri Vijay J. Parmar, Assistant Engineer-II/ASW, SMC (Mob. 9824598819), Team No. 5 & 6 shall be headed by Shri Sanjay Kapadi, Superintendent, SMC (Mob.9033585011) and Team No. 7 & 8 shall be headed by Shri Deepak Rathod, Statistical Assistant, SMC (Mob. 9558033571). The team leaders shall be responsible for ensuring that flooding & water logging shall not take place in any area of SMC or is immediately responded to.

Shri Piyush Patel, Foreman, SMC shall keep all the vehicles road worthy and shall provide all assistance to the teams constituted as and when required.

Team No. 1 to 4 will be working during day i.e. 8:00 am to 10:00 pm and Team No. 5 to 8 will be working during night i.e. 10:00 pm to 8:00 am and shall be responsible for controlling water logging activities, clearing drains and shall constitute as emergency response teams of Silvassa Municipal Council. During the entire monsoon season, as emergency response teams they shall also be available on duty for 24 Hrs a day and have to report within half an hour (30 min.) of being called. They also need to keep their mobile number working and functional during all hours failure to report to the duty or failure to answer call at any time shall be construed as breach of discipline.

Team No. 9 headed by Shri Maulik Dave, Swachhta Officer, SMC must be continuously available during the emergency and is directed to arrange all necessary equipment required for emergency response and provide it to the teams as and when required.

Team no 1 to 4 and 5 to 8 shall be under the direct supervision of Shri Anil B. Bhat, Municipal Engineer, SMC (Mob. 9924131972) and Dr. Rajeev Ranjan, Health Officer, SMC (Mob. 9824567137) respectively and shall be responsible for ensuring that flooding and water logging shall not take place in any area of Silvassa Municipal Council or is immediately responded to. The teams are directed to collect their emergency response material like torches, raincoat, gumboots, axes, crowbars and shovels from Shri Maulik Dave, Swachhta Officer, who is directed to hand it over to the respective teams. The teams will have to return the material after the season of monsoon is over.

This order shall take immediate effect.
