DECLARATION

WHEREAS, vide Preliminary Notification No. LAQ/Med-Coll/P.I/26/2018/461/Rev(S)/2019 dated 26.09.2019, it was Notified under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the lands described in the Schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of Construction of Medical College at village Sayli.

WHEREAS, as required under sub section (2) of section 15 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, No objection were received by the Department, and a report was submitted to the Appropriate Government i.e. Hon'ble Administrator, Daman & Diu and Dadra & Nagar Haveli to proceed with the acquisition process and the same has been approved by the Appropriate Government i.e. Hon'ble Administrator, Daman & Diu and Dadra & Nagar Haveli.

WHEREAS, the Hon'ble Administrator, Daman & Diu and Dadra & Nagar Haveli is satisfied, on the basis of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the Rehabilitation and Resettlement Scheme shall be applicable because there is displacement of 01 family due to the proposed acquisition process.

NOW, THEREFORE, it is hereby declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the said lands are required for the public purpose, namely for the purpose of Construction of Medical College at village Sayli.
