

OFFICE MEMORANDUM

Subject: Amendment of Recruitment Rules for the posts of Assistant Teacher, Primary / Upper Primary School Teacher (Elementary Education) under the Department of Primary Education, Dadra and Nagar Haveli, Silvassa.

As per the Office Memorandum (OM) vide No. AB-14017/61/2008-Estt (RR) dated 13/10/2015, issued by the Department of Personnel and Training (DoPT), the proposed amendment / revision of Recruitment Rules (RR) for the post of Assistant Teacher, Primary / Upper Primary School Teacher (Elementary Education) should be uploaded on the website of respective Ministries / Department for 30 days for inviting comments from the stake holders.

2. The Department of Primary Education, UT Administration of Dadra and Nagar Haveli, Silvassa has decided to amend / revise the Recruitment Rules (RR) for the post of Assistant Teacher, Primary / Upper Primary School Teacher (Elementary Education).

5. Hence, all the stakeholders are hereby requested to go through the aforesaid Recruitment Rules (RR) and furnish their comments (if any) to the Department of Primary Education, Dadra and Nagar Haveli, Silvassa within a period of 30 days from date of issue of this Notification.
6. in case, no comments receive within a period of 30 days of issuance of this Office Memorandum, the Department of Primary Education, UT Administration of Dadra and Nagar Haveli, Silvassa will proceed further for taking necessary action for amendment of aforesaid draft Recruitment Rules.

NOTIFICATION

In exercise of the powers conferred under proviso to Article 309 of the Constitution delegated to him vide Government of India, Ministry of Home Affairs, New Delhi's Notification No. 7/1/65-Est (A) dated 16th February, 1965 and Department of Personnel and Training, New Delhi O. M. No. AB-14017/13/2016-Estt. (RR) dated 18th January, 2017 and in super-session of Administration Notification No.A-1-11/92-ADM dated 8th July-1992, the Administrator, Dadra and Nagar Haveli hereby amends the following rules regulating the method of recruitment to the General Central Service Group 'B' (Non-Gazetted, Non-Ministerial) post of Assistant Teacher, Primary and Upper Primary Schools under the Department of Primary Education in the Union Territory of Dadra & Nagar Haveli Administration, namely:-

1. Short title and commencement:-

- i) These rules may be called, the Administration of Dadra & Nagar Haveli, Assistant Teacher, Primary / Upper Primary School Teacher (Elementary Education), Group 'B' (Non-Gazetted, Non-Ministerial) Recruitment Rules, 2019.
- ii) They shall apply to the post specified in Colum No.1 of the schedule to this rules.
- ii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the posts made on or after this date.

2. Number of Posts, Classification and Scale/Level of Pay:-

The number of the posts, their classification and the scale/level of pay attached thereto shall be as specified in Column 2 to 4 of the Schedule annexed to these rules.

Provided that the Administrator of Dadra and Nagar Haveli may vary the number of posts in column 2 of the said schedule from time to time subject to exigency of work.

3. Method of recruitment, age limit, qualification etc:-

The method of recruitment, age limit, qualification and other matters relating to the said posts shall be as specified in column 5 to 13 of the said Schedule.

4. Disqualification :-

No person (a) Who has entered into or contracted a marriage with a person having a spouse living, or (b) Who, having a spouse living, has entered into or contracted a
