DECLARATION

WHEREAS, vide Preliminary Notification No. LAQ/High Speed Rail Project/Naroli-Dhapsa/4/2017/448/2018 dated 31.07.2018, it was Notified under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the lands described in the Schedule hereto (hereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of Construction of Infrastructure project of Mumbai-Ahmedabad High Speed Rail Project (MAHSR).

WHEREAS, as required under sub section (2) of section 15 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, objection were accorded personal hearing by the Collector, Dadra and Nagar Haveli on 24.10.2018, 31.10.2018, 12.11.2018, 26.11.2018, 10.12.2018 and 23.01.2019.

WHEREAS, the Chief Project Manager, NHRCL vide its letter no. NHRCL(ST)/MA/AD/04/CW-DNH/0086.1/384 dated 27.12.2018 informed on 23.01.2019 during the hearing that a Memorandum with Terms and Conditions is signed between M/s. Bhilosa Industries Pvt. Ltd. and National High Speed Rail Corporation Ltd. for not acquiring land bearing survey no. 202/P, plot no. 2 & 3 admeasuring 1400 Sq.mt.

WHEREAS, on the basis of the statement of CPM, NHRCL, Surat, the Collector, Dadra and Nagar Haveli recommended to acquire 268 Sq.mt. & 673 Sq.mt. instead of 529 Sq.mt. & 1812 Sq.mt. from land bearing survey no. 202/P, plot no. 2 & 3 and the same was approved by the Appropriate Government i.e. Hon'ble Administrator, Daman & Diu and Dadra & Nagar Haveli.

WHEREAS, the declaration was issued vide no. LAQ/High Speed Rail Project/Naroli-Dhapsa/4/2017/158/19 dated 08.03.2019 for acquiring land bearing survey no. 202/P, plot no. 2 & 3 admeasuring 268 Sq.mt. & 673 Sq.mt. respectively and other survey nos. of Naroli and Dhapsa villages of Dadra and Nagar Haveli.

WHEREAS, the Chief Project Manager, NHRCL vide its letter no. NHRCL(ST)/MA/AD/04/CW-DNH/0086.1/1040 dated 26.07.2019 states that M/s. Bhilosa Industries Pvt. Ltd. has gone back in their commitments and have proposed for acquiring the additional area of land bearing survey no. 202/P, plot no. 2 & 3 admeasuring 261 Sq.mt. & 1139 Sq.mt. respectively which was dropped after Preliminary Notification.

NOW, THEREFORE, it is hereby declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the land mentioned in the statement are required in addition to the land mentioned in the Declaration no. LAQ/High Speed Rail Project/Naroli-Dhapsa/4/2017/158/19 dated 08.03.2019 for the public purpose, namely for the purpose of Construction of Infrastructure project of Mumbai-Ahmedabad High Speed Rail Project (MAHSR).


