2. The official shall be allowed to exercise option if any under FR 22 within one month of issuance of the order.
3. The grant of higher pay scale is subject to furnishing undertaking by the above employee that in the event of over payment which may be detected at a later state will be recovered from their pay.

The Head of office concerned is requested to ensure before issuing final order that 10 years of regular service of the official does not include the period of service rendered in State Government/Statutory Body/Autonomous Body/Public Sector Organization/Daily wages or contract basis service as period of past service in these bodies is not to be counted for grant of financial up-gradation under MACP Scheme.
5. The concerned Head of Office is also requested to ensure that the officials are clear from Vigilance angle.
