TERMS AND CONDITIONS

01. The envelop should be super scribed by words "**Quotation notice for Repairing of Bn Vehicle No.DN-09-A-0065 (TATA Bus)**".
02. The rates for the above items should be inclusive of all taxes & quoted for the unit shown against each items and for at Silvassa
03. The rate should be quoted by the firms who are able to repair the above vehicles on receipt of the clear supply order/work order by this department.
04. The material found defective or damaged or otherwise not as per specification given, shall be rejected. The firm should replace the same otherwise payment will not be made.
05. The payment will be made after full satisfaction of the representative dept.
06. This only quotation notice, the supplier should quote their rates in their own letter pad or on plain paper with their rubber stamp.
07. The quotation should be accompanied with EMD of `7000/- in the form of DD/FDR drawn in favour of undersigned.
08. the repairing garages/firm should own ability to repair the vehicle and vehicle should not transfer to other garages (like job work to third parties not allowed).
09. Concern MT I/C or MT staff should check the firm/garages reality as quoted, quotation first for further procedure.
10. On acceptance of rates, repairing should be completed within 15 days.
11. New paint works should be done after scraping entire body paint and anti rust proofing should be done before applying new paint.
12. Window glass rubber and channel filling should be done with only materials authorized to be fitted in TATA vehicle, no local made items/substandard items should be used.
13. Right to accept or reject any or all rates/quotation is reserved by undersigned.
