

1. The rate quoted will be valid for the period of one year from the date of engagement of the vehicle.
2. Tenders are invited for hiring of vehicle (Bolero) registered on or after 01/01/2016.
3. The tender period is for six months which may be extended for another six months, if needed on satisfactory service.
4. The Tender should be accompanied with a Demand Draft of Rs. 500/- in favour of Pollution Control Committee, DD & DNH payable at Silvassa as Tender Fees .
5. The Tender should also be accompanied with a Demand Draft/FDR of Rs. 20,000/- (Rupees Twenty Thousand only ) in favour of Pollution Control Committee, DD & DNH payable Silvassa as Earnest Money Deposit. The tender received without EMD will e summarily rejected.
6. The vehicle must have all the legal documents like valid registration certificate, comprehensive insurance and must have paid all Government dues like road tax etc. the vehicle has to be provided with Driver bearing valid driving license.
7. No advance payment will be made in any circumstances.
8. All bill should be in duplicate and shall invariably mention the number and date of the order. Payment will be given in every next month after the completion of 15 days.
9. The vehicle will be used for All the documents like attested photocopies of valid RC Book and Comprehensive Insurance etc. alongwith the tender shall be submitted in the office of the Pollution Control Committee, 2<sup>nd</sup> Floor, Sachivalaya, Silvassa.
10. The Vehicle will be used for 12 hours and also more when required by the department. The vehicle will be in possession of Member Secretary, Pollution Control Committee, DD & DNH, Silvassa or his authorized official of PCC.
11. The contractor will have to bear with all the expenditure for Diesel, Oil, Salary of Driver and repairing and maintenance charge of vehicle.
12. In case of breach of any terms and condition or failure to provide vehicle during the tenure or removal of the vehicle by owner or traveler or travel agency, the EMD shall be liable to be forfeited without any reference to the contractor.
13. As for as possible the driver will be granted weekly off on every Sunday. However his service will be utilized on Sunday also if required for vehicle in regular works and no extra charges will be paid.
14. Nothing extra will be paid towards the night hours or out station trips. The bill for travelling of vehicles shall be paid on monthly basis. No extra hours (over time ) will be paid.
15. All roads tolls/bridge tolls shall be reimbursed on production of proof of payment alongwith monthly bills.



16. The tender should be properly super scribed " Tender for Hiring of 01 no. of 7/8 Seater Four wheeler vehicle Jeep (Bolero) for the field use in the office of the Pollution Control Committee, DD & DNH, Silvassa."
17. During the repairing period of vehicle the contractor shall have to arrange for another vehicle so that Department works of supervision and inspection may not suffer.
18. Advance intimation shall be given to the Department for not sparing of vehicle on particular day. If vehicle will not available on day the proportionate amount will be deducted from the bill.
19. No separate agreement will be required to be signed by successful tenderer for hiring of vehicle. For legal purpose, the schedule of rate and terms and conditions shall be duly signed with stamp by the tenderer.
20. Right to Accept/reject the quotation in whole or in part without assigning any reasons is reserved by the undersigned.
21. Any dispute will be subject to Dadra & Nagar Haveli Jurisdiction only.
