**AWARD UNDER SECTION 23 OF THE RIGHT TO FAIR
COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION,
REHABILITATION AND RESETTLEMENT ACT, 2013**

PURPOSE OF ACQUISITION : Construction of approach road for High Level Bridge along Chikhali-Surangi road.

INTRODUCTION:

These proceedings are under provision of Section 23 of the Right to Fair Compensation and Transparency in Land Acquisition, rehabilitation and Resettlement Act, 2013 for determination of compensation in respect of net area of land proposed to be acquired admeasuring 1158.39 Sq.mt. for purpose of Construction of approach road for High Level Bridge along Chikhali-Surangi road. The land acquisition proceedings were initiated with the publication of Preliminary Notification under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

The Executive Engineer, PWD-II (Road), Dadra and Nagar Haveli had submitted a land acquisition proposal for Construction of approach road for High Level Bridge along Chikhali-Surangi road.

2. PUBLICATION OF NOTIFICATION AND ISSUE OF NOTICES:

The Preliminary Notification No. LAQ/HLB/Ch-Su-Road/12/2018/337/2019 dated 18/06/2018 was notified under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 that the land described in the schedule hereto

(thereafter referred to as the said land/lands) was needed or likely to be needed for the public purpose.

No objection were received by the Collector, Dadra and Nagar Haveli, which was submitted to the Appropriate Government i.e. Hon'ble Administrator, Daman & Diu and Dadra & Nagar Haveli, Silvassa seeking approval to proceed with acquisition process and the same was approved.

Vide Declaration No. LAQ/HLB/Ch-Su-Road/12/2018/460/Rev(S)/2019 dated 26/09/2019, it was declared under the provision under Section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 that the said lands were required for the public purpose namely for Construction of approach road for High Level Bridge along Chikhali-Surangi road.

In connection with acquisition of total land admeasuring 1158.39 sq.mt. for Construction of approach road for High Level Bridge along Chikhali-Surangi road, the Administration of Dadra and Nagar Haveli intended to take possession of the land, the particulars of which were given in the declaration u/s 19(1) of the Right to Fair compensation & Transparency in Land Acquisition Rehabilitation and Resettlement (RFCTLARR) Act, 2013.

To facilitate causation of the above requirements, public notice was served under section 21 of the RFCTLARR Act, 2013 that all persons having interest in the said land to appear personally or by agent or advocate before the Collector, Dadra and Nagar Haveli on 12/12/2019 and to state in writing and signed by the party or his agent, the following:

- a) The nature of their respective interest in their land;
- b) The amount and particulars of their claims to compensation for such interests;
- c) Their objection if any to the measurements made and marked on the referred area.

Under Section 21 of the RFCTLARR Act, 2013, the Government intended to take possession of the land in 30 days from the date of issue of the Notice and claims to compensations and rehabilitation and resettlement for all interests in the land, had to be submitted to the Collector for disposal within 30 days from the date of issue of the Notice.

The UT Administration of Dadra and Nagar Haveli is satisfied, on the basis of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, because no displacement of family/families will occur due to proposed acquisition process.

3. POSSESSION OF THE LANDS

The intension for taking possession of land proposed for acquisition of land in Dapada village of Dadra and Nagar Haveli was issued vide Notice No. LAQ/HLB/Ch-Su-Road/12/2018/543/Rev(S)/19 dated 13/11/2019.

All interested parties have been issued Notices under Section 21 of the said Act, the Collector shall give immediate notice of his awards to such of the persons interested.

Under sub section (1) & (2) of Section 22 of the said Act, the Collector may also require any such person to make or deliver to him a statement containing the name of every other person possessing any interest in the land or any part thereof as co- proprietor, sub-proprietor, mortgage, tenant or otherwise, and of the nature of such interest, and of the rents and profits, if any received or receivable on account thereof for three years next preceding the date of statement, every person required to make or deliver a statement under this section shall be deemed to be legally bound to do so within the meaning of section 175 and 176 of the Indian Penal Code (45 of 1860).

4. JOINT MEASUREMENT

The Collector, Dadra and Nagar Haveli had directed for joint measurement of the land through the Survey and Settlement Department. The joint measurement of land was carried out by Survey and Settlement Department along with officials of the PWD-II (Road).

5. OWNERSHIP

Names of the persons of whose land under acquisition was standing in the record of rights were ascertained from the revenue records and the same are shown in Award statement. No other person except shown in the Award statement has claimed ownership or claim of compensation with regard to their land under acquisition and compensation thereof.
