


LIMITED TENDER NOTICE

Terms & Conditions

1. The rates should be quoted on letter head only in figures and words inclusive of all charges and all rates and taxes.
2. The envelope should be super-scribed as "Quotation for Post Enumeration Survey (5% Sample checking) of U-DISE data in the UT of Dadra and Nagar Haveli for SSA due on 28/07/2018."
3. The tender fees for an amount of Rs.1000/- (Rupees one Thousand only) in form of Demand Draft only from any Nationalized/Schedule Bank drawn in favor of the "State Project Director, SSA, Dadra and Nagar, Silvassa" should be enclosed with the bid.
4. The Bidder shall have to pay E.M.D. in form of FDR of any Nationalized/Schedule Bank of ₹ 1,900/- in favor of State Project Director, Samagra Shiksha Abhiyan, D.&N.H., Silvassa.
5. Quotation received after due date and time will not be taken in to consideration.
6. Actual sample of schools will be drawn by the agency entrusted the task of data checking. While drawing school sample, it should be ensured that schools located both in rural and urban areas are selected as well as the sample drawn should also include all types of schools across school managements. Due consideration should also be given to schools pre-dominantly located in SC, ST and minority areas.
7. Sample format for conducting 5% Sample checking of U-DISE data in the UT of Dadra and Nagar Haveli should be provided to agency by the undersigned.
8. The agency would cover Primary/Upper Primary/Secondary/Higher Secondary schools of UT of Dadra and Nagar Haveli.
9. The agency entrusted the task of sample checking of the data would be required to submit report with Soft copy (CDs). The report should contain Methodology adopted by agencies, Samples of Survey, Major findings, Comparison of Post Enumeration Survey (PES) with U-DISE Data, Suggestions, Investigator's Feedback/ Conclusion and Future course of action. They should also comment on coverage of schools in the district.
10. Company must be registered by Govt. /Pvt. in the field of survey. Company should have provided minimum five years of experience certificate for same field.
11. No Advance payment or part payment will be made. Payment will be made after successful completion the work.
