**Criteria/Guidelines for Selection/Nomination of applicants against the Central Pool Seats for Medical Courses (MBBS/BDS/BAMS/BHMS) as being allotted to the U.T. of Dadra & Nagar Haveli by Government of India for the academic year 2018-19.**

In supersession of all previous instructions issued prescribing guidelines in respect of Selection/Nomination of applicants, against the Central Pool seats for Medical Course allotted to this Union Territory by the Govt. of India, the following guidelines are hereby prescribed and shall come into force with immediate effect.

**1. MODE OF APPLICATION**

- (i) The applicant desiring to avail the benefit of Central Pool seats for Medical Courses shall submit an application in prescribed form in hard copy (**Appendix 'A'**) to the Director of Education, DNH on advertisement of such seats by the Directorate of Education.
- (ii) Wide publicity shall be given to this order through Dadra & Nagar Haveli District Panchayat, Silvassa Municipal Council, Head Masters of High/Higher Secondary Schools and all Libraries of Dadra & Nagar Haveli and also in two newspapers.
- (iii) Application Form shall be available from the Directorate of Education on any working day.
- (iv) The Application Form duly filled in all respects should reach on or before prescribed date to the Directorate of Education along with the following Self Attested documents.
  - a. Statement of marks of SSC.
  - b. Statement of marks of HSCE.
  - c. School Leaving Certificate.
  - d. Attempt Certificate of HSCE from School.
  - e. Copy of NEET Marksheet.
  - f. Certificate showing applicant has continuously studied for at least **5 years** i.e from Class 8<sup>th</sup> to 12<sup>th</sup>, in any of the recognized schools of U.T. of Dadra and Nagar Haveli.
  - g. Domicile Certificate of Parents/Guardians issued by Mamlatdar Silvassa/Khanvel, Dadra & Nagar Haveli.

- h. Service certificate of parents from the Head of Office in case of applicants falling in the Third priority. In case of Bank Employees, service certificate from the Regional Manager of the concerned bank be produced .
  - i. Caste Certificate for SC/ST/OBC in prescribed format from the Mamlatdar Silvassa/Khanvel, Dadra & Nagar Haveli and for OBC category certificate should be within one year mentioning whether the applicant is from a Creamy layer or Non-Creamy Layer. Non-Creamy Layer OBC Certificate issued prior to 1<sup>st</sup> April 2018 shall not be accepted in any case.
  - j. Dependant Certificate issued by the Mamlatdar Silvassa/Khanvel, Dadra & Nagar Haveli, will have to be attached to the application in case of those who are claiming guardianship of the wards.
  - k. Disability Certificate of applicants who are Physically Handicapped from the Disability Assessment Board of Dadra & Nagar Haveli.
- (v) Necessary acknowledgement shall be issued by the Directorate of Education in prescribed form upon receipt of hard copy of application duly filled in all respect along with necessary enclosures.

## **2. ELIGIBILITY CRITERIA.**

- A. He/She is an Indian National.
- B. He/She has completed age of 17 years at the time of admission or will complete the age on or before 31<sup>st</sup> December of the year of his/her admission to the 1<sup>st</sup> year of Medical Courses.
- C. The upper age limit for applicants is 25 years as on 31<sup>st</sup> December-2018. This upper age limit shall be relaxed by a period of 5 years for the applicants of Scheduled Castes/Scheduled Tribes.
- D. The allotment of the Central Pool seats will be made in the following order of priority:

### **[1] First Priority :**

Applicant(s) whose parents/ guardian (in case Father and/or Mother is not alive) have Domicile Certificate of U.T. of Dadra & Nagar Haveli issued by the Mamlatdar Silvassa/Khanvel.

The applicant(s) should have continuously studied for at least 5 years i.e From Class 8<sup>th</sup> to 12<sup>th</sup> in any of the recognized schools of U.T. of Dadra & Nagar Haveli.
