1. The rates quoted should be inclusive of all taxes.
2. All other Taxes/Duties/Royalty charges payable on the sales transport etc. Within and/or outside the state of the Mechanic shall be borne by the Mechanic only.
3. The rates should be quoted only for the items specified in the list requirements with labour charges and should be for the items of given specification. **The warranty of the work should be of one year.**
4. The tenderer should enclose Earnest Money Deposit of **Rs.7,825/-** (Rs.seven thousand eight hundred twenty five only) drawn in form of FDR/DD of any Nationalized Bank/Scheduled Bank payable at Silvassa drawn in favour of the Deputy Superintendent of Police (HQ) . Tenders received without EMD will not be accepted and summarily be rejected.
5. In case of failure to replace the accepted and rejected articles from the Mechanic made as mentioned in the conditions, the loss undergone by the government will be recovered from the tenderer's EMD or payment of due of bills to the extent required.
6. The tenders will be opened in presence of tenderers or their representatives, if present in the office of the tender inviting officer.
7. The tender received which do not confirm with the terms and condition of this office will be summarily rejected. However, if any firm desires to consider exemption from Registration with DGS&D/GeM should be attached to their Tender.
8. If the mechanic whose tender is accepted fails to execute the repair/replace within stipulated time, the EMD of such tenderer will stand forfeited to the Government.
9. No separate agreement will be required to be signed by the Mechanic for the purpose of contact for repair/replace. Tender Notice shall be considered as acceptance of all above terms and conditions for supply of all legal purposes.
10. If possible, the tenders will be opened on the same day after 15.00 hours in the presence of the tenderers who may be present at the time of opening of tender.
