Terms and Conditions for fixation of the agency for supply of Hybrid Paddy Seeds for the farmers during 2019-20.

1. The rates quoted should be strictly for F.O.R Silvassa and will be valid and operative for one year.
2. The rates quoted should be inclusive of all taxes.
3. No extra charge for packing, forwarding or insurance will be paid on the rates quoted.
4. The rates should be quoted only for the items specified in the list of requirement and should be for the items of given specifications.
5. Rates quoted for items other than the required specification will not be considered.
6. **The tenderer should enclose tender fee of ₹ 500/- (Rupees five hundred only) Non-refundable, drawn in form of DD** from any Scheduled/Nationalized Bank payable at Silvassa drawn in favour of the Deputy Director of Agriculture, Silvassa. Tenders received without tender fee will not be accepted and summarily be rejected.
7. **The tenderer should enclose Earnest Money Deposit of ₹ 46,500/- (Rupees: Forty Six Thousand Five Hundred only) drawn in form of Fixed Deposit Receipt** from any Scheduled/Nationalized Bank payable at Silvassa drawn in favour of the Deputy Director of Agriculture, Silvassa. Tender received without Earnest Money Deposit will not be accepted and summarily be rejected.
8. The amount of Earnest Money Deposit paid by the tenderer whose tenders are not accepted will be refunded to them. No E.M.D. will be refunded to the successful bidder whose tender is accepted for supply of the materials before expiry of time limit prescribed by the tender inviting officer.
9. The tender received which do not confirm with the terms and conditions and specifications of this will be summarily rejected.
10. The supplies of inferior quality of seeds other than that ordered specified and or spurious seeds will not be accepted. The supplier will have to replace the same at his own risk and cost. Intimation of non – acceptance of any item will be informed to the supplier within 03 days from the date of receipt of the seeds and the same will be returned to the supplier at his own cost and risk. However, if there is no communication from the supplier the Tender Inviting Officer will not be responsible for any damage, loss etc. of such rejected material.
11. In case failure to replace the accepted and rejected seeds from supplies made, as mentioned in the conditions, the loss undergone to the Government will be recovered from the Security Deposit / Earnest Money Deposit or from the payment due of bill of the supplier to the extent required.

12. The bill should be pre-receipted in duplicate and should invariably mention the number and date of supply order.
13. The tender will be opened in the presence of tenderers or their representatives if presence in the office of the tender inviting officer.
14. On receipt of supply order, the seeds should be supplied within stipulated time failing which action will be taken.
15. The notified hybrid paddy seeds should be supplied in good condition within 07 days from the receipt of the supply order. Defective seeds in any way will not be accepted.
16. Right to accept or reject any or all tender in part or whole without assigning any reason is reserved with the tender inviting officer and his decision on all matter relating to acceptance or rejection of the tender as a whole or in part will be final and binding to all.
