**NOTICE**

It is hereby informed in reference to the Orders No. DP/EDN/SSA/2017/592/2752 dated 26.09.2017 and No. DP/EDN/SSA/2017/592/3167 dated 06.11.2017 that your service as Assistant Teacher under the scheme of Sarva Shiksha Abhiyan Department of Primary Education, Dadra and Nagar Haveli, Silvassa for the period from 01.05.2017 to 31.10.2017 and from 03.11.2017 to 30.04.2018 respectively has been expired on 30.04.2018.

And whereas Shri M. A. Patel and 19 others have filled M. P. No. 119/2014 & 292/2014 challenging an Order No. DP/EDN/EST/Regular/2010/2725 dated 18.11.2013 passed by the Chief Executive Officer, District Panchayat suspending the order of regularization of Primary School Teacher. The Hon. CAT, Mumbai Bench vide Order dated 12.12.2013 has ordered to maintain Status Quo in respect of petitioners in O. A. No. 742/2013. The said OA is still pending.

And whereas Shri Suresh Dahyabhai Mahala & 82 others have directly approached Hon. High Court by way of Writ Petition No. 11444/2015 for regularization as Primary School Teacher in District Panchayat, Dadra and Nagar Haveli, Silvassa and the Hon. High Court vide Order dated 04.12.2015 directed UT Administration to take any action against petitioners by giving 3 weeks prior notice.

Further, as per the instruction contained in the Letter received from the Govt. of India, MHRD, New Delhi vide No. F. No. 18-1/2013-EE-4 dated 28<sup>th</sup> March, 2014, a person to be eligible for appointment as a teacher is that he/she should pass the Teacher

Eligibility Test (TET) conducted by the appropriate Government. You have not acquired the TET qualification till date and hence you are not eligible to continue on Contract basis. The department has initiated the process for inviting fresh application from eligible candidates by issuing Advertisement in News Paper & by posting on official website of UT of Dadra and Nagar Haveli.

This issues with the approval of the Hon. Administrator, DD & DNH vide dated 19.05.2018 on file No. EDN/SSA/2017/592 at N/225.
