ORDER
(u/s 144 of Cr.P.C.)

WHEREAS, the cases relating to Coronavirus (COVID-19) which is declared as pandemic by the World Health Organisation (WHO) has been reported to be spreading in the nearby states of the Union Territory of Dadra & Nagar Haveli and Daman & Diu;

AND WHEREAS, the U.T. Administration intends to contain the said virus and prevent it from spreading in this territory by dealing with this pandemic head-on through effectively utilizing the available resources (both Human and other resources);

AND THEREFORE, in view of above and in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, Silvassa, hereby order that the following establishments and essential services in Dadra & Nagar Haveli shall remain operational until the outbreak of Coronavirus (COVID-19) is under control and situation resumes to normalcy.

1. Department of Police;
2. Department of Fire and Emergency Services;
3. Directorate of Medical & Health Services;
4. Silvassa Municipal Council;
5. District Panchayat; and
6. Dadra & Nagar Haveli Power Distribution Corporation Ltd.

It is further directed that officials / officers / staffs including outsourced, contractual, daily wages etc. of the above establishments shall not take leave without prior approval of the Officer In charge and the same shall be intimated to this Office.

This Order shall come into force immediately from the date of issue and shall remain in force until 60 days from the date of issue.

As the Order cannot be served individually, the Order is put in the public domain for information and necessary action.
