The Deputy Director of Agriculture, Dadra & Nagar Haveli, Silvassa on behalf of the President of India hereby invites sealed Tenders from the Manufacturers/Authorized Distributors/Authorized Dealers for Purchase of Mango & Rayan Seedlings so as to reach the office of undersigned on or before 26/10/2018 at 15.00 hours by RPAD/Courier/tender box kept in the office.

The blank tender form will be issued from 18/10/2018 to 25/10/2018 upto 15.00 hours.

The tender in prescribed form accompanied by EMD of Rs.11200/- (Rupees eleven thousand two hundred only) in the form of FDR of any Nationalized Bank/ Scheduled Bank should reach the undersigned by RPAD/ Courier or to be deposited in the tender box kept in the office of the undersigned on or before 15.00 hours up to 26/10/2018. The envelope should be superscribed with words as **“TENDER FOR PURCHASE OF MANGO AND RAYAN SEEDLINGS”**. The tenders will be opened on

the same day, if possible at 16.00 hours in the presence of intending tenders who may be present at that time.

Conditions for Purchase of Mango and Rayan seedlings

1. The rates quoted should be strictly for free delivery at FOR, Silvassa and will be valid and operative for one year.
2. The rates quoted should be inclusive of all taxes (GST).
3. No extra charge for packing, forwarding or insurance will be paid on the rates quoted.
4. The rates should be quoted only for the items specified in the list requirements and should be for the items of given specifications.
5. The decision of the Tender Inviting Officer for acceptance or rejection of any articles supplied including the decision for equivalent specifications, standard and quality etc. of articles shall be final.
6. The intended Tenderer is required to deposit an amount of **Rs.500/-** in the form of FDR/Demand Draft drawn in favour of Deputy Director of Agriculture, Dadra and Nagar Haveli, Silvassa at the time of issue of Tender Form
7. The tender should enclose Earnest Money Deposit of **Rs.11200/-** (Rupees eleven thousand two hundred only) drawn in form of F.D.R from of any Nationalized Bank /Scheduled Bank payable at Silvassa drawn in favour of the Deputy Director of Agriculture. Tenders received without Earnest Money will not be accepted and summarily be rejected
8. The amount of earnest money deposited by the successful bidder will be adjusted against the amount of security deposit or will be refunded as may be convenient.
9. The amount of Earnest Money Deposit paid by the tenderer whose tenders are not accepted will be refunded to them. **No E.M.D.** or Security Deposit will be refunded to the successful bidder whose tender accepted for supply the materials before expiry of time limit prescribed by the tender inviting officer.
10. In case failure to replace the accepted and rejected articles from supplies made, as mentioned in the conditions, the loss undergone by the Government will be recovered from the Earnest Money Deposit or from the payment due of bill of the supplier to the extent required.

11. In case of failure to supply **Mango and Rayan seedlings** ordered for as per condition & stipulated time, the same **Mango and Rayan seedlings** will be obtained if required from the tenderer who offered next higher rates or from any other sources as may be *decided by the tender inviting officer & the loss to the Government on account of such purchase* shall be recovered from the earnest money deposit.

12. The bill should be pre-receipted in duplicate and it should invariably mention the number and date of supply order.

13. The tenders will be opened in presence of tenderers or their representatives if present in the office of the tender inviting officer.

14. The right to accept or reject without assigning any reasons or all tender in part of whole is reserved with the Tender Inviting Officer and his decision (S) on all matters or in part will be final and binding to all.

15. The tender received which do not confirm with the terms and condition of this office will be summarily rejected.

16. If the supplier whose tender is accepted fails to execute the supply order within stipulated time, the **E.M.D** of such supplier will stand forfeited to the Government.

17. After receipt of the supply order, the **Mango and Rayan seedlings** will have to supply within 30 days failing which action will be taken as per condition No.10.

18. If possible, the limited tender will be opened on the same day at **16.00 hrs** in the presence of supplier who may be present at the time of opening of limited tender
