In exercise of the powers conferred by the provision of Article 309 of the Constitution, read with Government of India, Ministry of Home Affairs, New Delhi Order No. 7/1/65 EST (A) dated 16.02.1965 and the Department of Personnel and Training OM No. AB-14017/61/2008-Estt (RR) dated 24th March, 2009 and in supersession of earlier Recruitment Rules, the Administrator, Daman & Diu and Dadra & Nagar Haveli is pleased to make the following Rules relating to the General Central Services Group 'B' Gazetted Non-Ministerial, post of Assistant Engineer/Assistant Surveyor of Works /Engineering Assistant (Civil) in the Public Works Department, Union Territory of Dadra & Nagar Haveli Administration namely:-

1. Short Title and commencement:-

- (i) These rules may be called the Administration of Dadra and Nagar Haveli Assistant Engineer/Assistant Surveyor of Works /Engineering Assistant (Civil) Group 'B' (Gazetted, Non-Ministerial) posts Recruitment Rules, 2019.
- (ii) These shall apply to the posts specified in column-1 of the Schedule to these rules.
- (iii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the various posts made on or after this date.

Number of Posts, Classification and Level in the Pay Matrix :-

The number of the posts, classification of the said posts and the Level in the Pay Matrix attached thereto shall be as specified in column 2 to 4 of the Schedule to these rules

Provided that, the Administrator of Dadra & Nagar Haveli may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.

3. Method of Recruitment, Age limit, Qualifications etc .:-

The method of recruitment to the said post, age limit, qualifications and other matters relating therewith shall be as specified in column 5 to 13 of the aforesaid Schedule.

4. Disqualification:-

No person, (a) who has entered into or contracted a marriage with a person having a spouse living or, (b) who having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the service.
