Right to accept or reject any or all tenders in part or whole without assigning any reason thereof is kept reserved with the tender inviting officer



Technical Bid

1. The Limited Tender Notice shall be submitted in Sealed cover with Super scribed words **“Limited Tender Notice procurement and installation of CCTV Cameras at Sub-Jail, Silvassa”**.
2. The Rates should be offered in a schedule above.
3. The Rates should be F.O.R. Delivery upto office at Silvassa including packing, forwarding charges, VAT/CST Charges, Transportation Charges installation, testing commissioning etc. **Rates quoted should be valid for the period of two year from the date of issue of work order.**
4. Rejected/Inferior Quality materials should be returned at supplier risk and cost within 15 days on receipt of materials. The materials/items supplied should be of standard quality and confirming to the specifications given in the schedule/supply order.
5. Payment will be made only after successful delivery on each orders of above material at the locations approved by the Authority.
6. The Bidder shall have to submit the copy of Bank Account Number, Branch Name, and IFSC code for releasing payment through e-payment system.
7. The copy of Registration GST/VAT/CST No., PAN No. of the Agency/Dealer/Authorized Dealer shall have to be enclosed duly attested.
8. The qualified bidder/supplier/ shall have to provide the said articles as and when required within 10 days from the issue of Supply orders.
9. **The bidders/suppliers shall have to pay EMD of Rs. 6000/- (Rs. Six Thousand Only) in form of DD and Non Refundable Tender Fee of Rs. 500/- (Rupees Five Hundred only) in form of DD from any Bank in the name of Mamlatdar, Dadra and Nagar Haveli, Silvassa Payable at Silvassa.**
