DRAFT NOTIFICATION

In exercise of the powers conferred under section 10(i) (b) of National Food Security Act, 2013 (No. 20 of 2013), the Administrator of Union Territory of Dadra and Nagar Haveli hereby frames the following draft guidelines for identification of priority households for the purposes of the said Act. The objections and suggestions in the matter may be submitted within 30 days to the Secretary (Food & Civil Supply), Dadra and Nagar Haveli.

Criteria for eligible households of (PHH) under the National Food Security Act, 2013 in the U.T. of Dadra and Nagar Haveli.

Priority households shall be those households which qualify on both (1) Inclusion Criteria, and (2) Exclusion Criteria.

1. **INCLUSION CRITERIA** : Following Category of people will be included under priority households.
 - (1) All the Below Poverty Line households.
 - (2) Socially and Occupationally Vulnerable Groups.

- (i) All homeless households.
- (ii) All households headed by a single woman (Unmarried/separated/ deserted).
- (iii) All Scheduled Tribes households.
- (iv) All Scheduled Castes households.
- (v) All households of landless Agricultural laborers.
- (vi) All households owning land up to 1.00 acres in the rural area and 900.00 Sq.fts (i.e 83.61 Sq. mts) in the Urban area in the U.T. Administration of Dadra and Nagar Haveli.
- (vii) All households headed by a person registered as an unorganized labour under the provisions of the Unorganized Worker's Social Security Act, 2008 (33 of 2008).
- (viii) And households of all other Occupationally vulnerable groups like Fishermen, Rag-Pickers, unskilled construction workers, porters, casual daily wage labourers, casual domestic labourers, cycle rickshaw drivers, unskilled workers in small household enterprises, unskilled workers in household industries, Sweepers/ Sanitation workers, disabled persons.
- (ix) Transgender
- (3) All households living in Kutcha House.

2. **EXCLUSION CRITERIA:** Following Categories of households will be automatically excluded from the ambit of priority households.

- (1) All households having annual income more than Rs. 1,00,000/-.
- (2) Households having an income tax payer.
- (3) Households where any member owns a light motor vehicle (Four Wheeler) or heavy vehicle, except maximum one commercial vehicle for earning livelihood.
- (4) All Government employees (other than contractual/Daily Wagers) of Government of India, State Governments and Union Territories or its boards/Corporations/enterprises/ undertakings, other Autonomous bodies/Authorities such as college, Municipal Councils, etc.
