
Sir/Madam,

**OFFICE MEMORANDUM**

Sub: Implementation of India Code Implementation System (ICIS)

The undersigned is directed to say that the Legislative Department, Ministry of Law & Justice in collaboration with NIC is developing a new India Code Portal for uploading of all Legislative documents including Acts, subordinate legislations, rules, regulations and notifications etc., in order to implement the directions of the Hon'ble High Court of Delhi in the matter.

2. Further, Cabinet Secretariat has constituted a committee to oversee the implementation and directed the Ministries to generate a year wise and subject wise list of all existing and repealed acts along with list of rules, regulations and notifications etc framed under each of such Acts pertaining to their Ministry/ Departments and Statutory Bodies. During a meeting in Cabinet Secretariat on 10.01.2018, it was learnt that NIC would make new India Code Portal fully operational in 10 days, following which all Ministries/ Departments will have to upload the requisite information on the new India Code Portal immediately.

3. All the Divisions had been requested to provide the consolidated material to CIC Division vide CIC Division's O.M. of even number dated 19.12.2017 and reminder dated 11.01.2018. However material from your Division is awaited.

4. It is, therefore, requested that requisite information/material may be forwarded to CIC Division immediately to enable us to comply with Cabinet Secretariat's instructions.
