The Social Welfare Department, Dadra and Nagar Haveli invites the application from the interested persons to be appointed as Members (Social Workers) of Juvenile Justice Board (J.J.B). The Board shall consist of Judicial Magistrate of First Class and two Social Workers of whom atleast one Social Worker shall be a Women forming a bench.

The Social Workers to be appointed as Members of the Juvenile Justice Board shall be not less than thirty-five years of age and shall have at least seven years of experience of working with children in the field of education, health, or welfare activities, or should be practicing professional with a degree in child psychology or psychiatry or sociology or in field of law.

The Board shall have tenure of three years and the appointment of Members shall be co-terminus with the tenure of the Board.


The Members of the Board shall be eligible for appointment for maximum of two terms.
