TERMS AND CONDITIONS

Terms and Conditions for purchase of Multiskan GO without cuvette, 100-240V, 50/60Hz system for Govt. Veterinary Hospital, Dokmardi-Amli.

Limited E-Tender Notice No. AHD/Accts/Multiskan/2017-18/211 Dated:29/01/2018.

- (1) The rate(s) quoted will be valid and operative for supply orders issued up to 31/03/2018.
- (2) The rates should be quoted inclusive of all taxes and FOR Govt. Veterinary Hospital, Dokmardi-Amli.
- (3) All other Taxes/Duties/Royalties charges payable on the Sales / transport / Vat etc. within or outside the State, the same shall be payable by the supplier.
- (4) No extra charges for Packing, forwarding and Insurance etc. will be paid on the rates quoted.
- (5) The rates should be quoted only for the items specified in the list of requirements and should be for the items of given Specification/Mark/Manufacture.
- (6) Rates quoted for items other than the required Specification/ Mark/Manufacture will not be considered.
- (7) Where Specifications / Mark / Manufacture are not specified by this office, the rate should be quoted only for the 1st Class and Standard quality only
- (8) The decision of the Tender Inviting Officer for acceptance/rejection of any articles supplied including the decision for equivalent specifications, standard and quality etc. for articles shall be final.
- (9) The tenderer should send Earnest Money Deposit of ₹59,000/- in form of Demand Draft from any Commercial Bank in favour of the Deputy Director (Animal Husbandry), Dadra and Nagar Haveli, Silvassa. Tender offered without Earnest Money Deposit will be summarily rejected.
- (10) (a) The successful tenderer will have to pay within 10 days from the date of demand an amount equal to 2.5 % of the total value of Articles, that may be ordered etc., as an amount of Security Deposit.

(b) Non receipt of Security Deposit within stipulated time limit will result in automatic cancellation of the order for supply without any intimation.

(c) However, in case, if any articles are received for which the Security Deposit may not have been deposited, the full security deposit as may be due from the supplier will be recovered from the bill (s) for such articles.
- (11) The amount of Earnest Money paid by the successful Tenderer(s) will be adjusted against the amount of Security Deposit to be paid by the successful tenderer.
- (12) The amount of Earnest Money paid by the Tenderer(s) whose tenders are not accepted will be refunded to them. No Security Deposit will be refunded before expiry of guarantee period, if any or any such date/period, as may be mutually agreed upon.
- (13) Only on satisfactory completion of the supply order and on payment of all bills of the supplier, as to be admitted for payment, the amount of Security Deposit/Earnest Money Deposit will be refunded after expiry of guarantee period, if any, or any such date/period as may be mutually agreed upon.
- (14) The Head of Officer will be consider extension of time limit for remitting the Security Deposit as demanded. However, in case of denial to consider such extension, the Supplier is bound to abide by the limit given and liable to make good any loss to the Government on account of his failure to abide by the time limit.

- (15) No advance payment will be made in any circumstances.
- (16) The Supply of Medicine Store/ equipment etc. of inferior quality, standard or of different specifications other than that orders specified and /or incomplete or broken articles will not be accepted. The supplier will have to replace the same at his own cost and risk, intimation of non acceptance of any Medicine stores, Machinery and Equipment etc. will sent to the supplier within 10 days from the date of receipt of the stores and the same will be returned to the supplier at his own cost and risk, if he so desires and intimated accordingly within 15 days from the date of dispatch of intimation of the non-acceptance. However, if no communication is received within 15 days from the date of communication, the tender inviting officer will not be responsible for any damage, loss etc. of such rejected articles.
- (17) In case, failure to replace the accepted and rejected articles from suppliers made as mentioned in the conditions, the loss undergone by the Government will be recovered from the suppliers Security deposit/Earnest Money or payment of any bill(s) to the extent required.
- (18) In case of failure to supply the stores, Machinery and Equipment etc. ordered for as per conditions and within the stipulated time, the same articles will be obtained, if required from the tenderer who offered next higher rates or from any other sources, as may be decided by the tender inviting Officer and the loss to the Government on account of such purchase(s) shall be recovered from the former supplier's Security Deposit/Earnest Money or bills payable. The suppliers shall have not any right to dispute with such procedure.
- (19) Extension of time limit for suppliers may be considered by the Tender inviting Officer up to 50% of the original stipulated time for supplies and beyond that by the Secretary (A.H.), D & N.H. or Competent Authority to accord Expenditure Sanction or enter in to contact with reference to the amount involved in the contract. However extension of time limit will be considered in very exceptional circumstances and at the desecration of the above authorities and supplier cannot claim it as matter of right. The extension so granted may be with levy of Compensation for delay in execution of supply order up to 5% of the cost the delayed quantity, Competent Authority competent to grant extension of time limit provided such request is made in time depending upon the circumstances and such decision in the matter will be final.
- (20) If at any time after the order for supply of Medicine/Machinery/Stores/equipment, the Tender inviting Officer shall for any reason whatsoever not require the whole or part of the quantity thereof as specified in the order, the tender Inviting Officer shall give notice in writing of the fact to the supplier(s) might have deprived from the supply of articles In full but which did not deprived in consequence of the full quantity of articles not having been purchased or shall have any claim for compensation by reason of any alteration which shall involve any curtailment of the supply originally contemplated.
- (21) The Earnest Money (s) /Security Deposit(s) paid by the tender(s) earlier against any tender(s) or Supply order(s) is/are not adjustable with Earnest Money or Security Deposit required by these conditions.
- (22) All bills should be in triplicate & pre-receipted and should invariably mention the number and date of supply order.
- (23) All bills for amount above ₹ 5,000/- should be pre-receipted on a Revenue stamp of proper value. Bill for amount above ₹ 5,000/- which are not pre receipted on Revenue stamp of proper value will not be accepted for payment.
- (24) The tender will be opened in presence of Tenderers or their representatives, if any present in the office of the Tender Inviting officer.
- (25) Right to accept or reject without assigning any reasons any or all tenders in part or whole is reserved with the Tender Inviting Officer and his decision(s) on all matters relating to acceptance or rejection of the tenders as a whole or in part will be final and binding to all.
- (26) The tenders/offer received do not confirm with the terms and conditions of this office

will be summarily rejected. However, if any firm desires to consider exemption from payment of Earnest money deposit certified copies of its Registration with D.G.S. & D should be attached to their tenders.

- (27) If the tenders whose tender is accepted fails to execute the Supply order within stipulated time, the Earnest Money Deposit of such tenderer will stand forfeited to the Government.
- (28) In case, the supplier does not execute the supply order in full placed with him, the EMD of the supplier will be forfeited to the Government and the contract for the supply shall stand terminated with no further liabilities on either party to the contract.
- (29) No separate agreement will be required to be signed by the successful tenders for the purpose of the contract for supply, Rates tendered/offered in response to the concerned Tender shall be considered as acceptance of the above terms and condition for supply for all legal purpose.
- (30) Supplier has to submit the tender fees and Earnest Money Deposit (EMD) in the form of Demand Draft in favour of Deputy Director (Animal Husbandry) Dadra & Nagar Haveli, Silvassa drawn from any Commercial Bank.
- (32) The tenderer may be called for a demonstration of the items quoted for which he/she/they will be informed one week in advance for arranging the necessary demonstration on a suitable date and time failing which the tender will be rejected
- (33) The tenderer should give the guaranty/warranty for the period of not less than one year from the date of installation against any manufacturing defect.
- (34) AMC : The rate of Annual Maintenance Contract (AMC) should be for the period of one year from the expiry of warranty/guarantee and should be written separately in the financial year wise. The decision to accept the tender with or without A.M.C. is reserve with the Tender Inviting Officer.
- (35) As and when necessary, any employee of this office shall be given training for the use of equipments by the supplier at their cost.
- (36) The successful tenderer should install and commissioning the system/equipment at the site suggested by the Tender Inviting Officer.
- (37) The tender document shall be duly signed by the supplier.
- (38) The Tenderer has to submit the authorization letter from the principal manufacturing company.
- (39) The successful tenderer shall be bound to provide training if any required without any extra charges whenever required by employee of this department. The tenderer shall be bound to give assurance for undertaking the Annual Maintenance Contract after the expiry of guarantee/warranty period.
- (40) The successful tenderer/suppliers/Dealers has to supply the materials within 15 days from the date of issue of supply order without fail.

Technical Specification for Multiskan GO without cuvette, 100-240V, 50/60Hz system

- A UV-visible spectrophotometer both for cuvette and microplate reading option.
- A monochromator based UV/Vis spectrophotometer with Xenon Flash lamp as light source and photo multiplier tube (PMT) as detector, for better performance.
- The system is able to read 96 & 384 well plates and standard cuvette as well as low volume cuvettes of any path-length.
- Instrument is able to provide the wavelength range from 200nm to 1000nm with 1 nm steps.
- Instrument should have spectral scanning option with Cuvette and Plates for standardizing new assays.
- The applications include nucleic acid quantification, protein assays, enzyme kinetic assays, immunoassays (ELISA), cell toxicity assays, apoptosis and reporter gene assays.
- The instrument has inbuilt incubation and linear shaking options for ELISA, enzyme kinetic assays etc.
- Incubation temperature: from ambient +2 °C to + 45 °C.
- Measurement speed should be 6 sec. for 96 well and 10 sec. for 384 well plate.
- Instrument should be an open system and able to accommodate any consumables from any manufacturer

- The instrument has a memory of 100 inbuilt protocols in stand-alone mode and has color display for better visualization.
- Analysis software should be supplied with the instrument and has unlimited user system license.
- The instrument has USB port for the easy data transfer.
- Self diagnostic option to give a guaranteed high quality data.
- Option for Quick and easy measurement of low sample volumes down to 2 µL.
- An ideal tool for photometric DNA or RNA quantification and purity analysis.
- dsDNA detection range from a few micrograms to a few milligrams per milliliter.
- 16 sample positions for quick and easy measurement of sample volumes down to 2 µL.
- Quick and easy to wipe off the samples in serial measurements.
- Ready-made software sessions for nucleic acid analysis.

Analysis software should have :
