Preliminary Notification

Whereas, it appears to the Collector that a total of **320 Sq.mt.** of land is required in Athola Village of Dadra and Nagar Haveli for public purpose, namely, **for Construction of Check dam cum Causeway near village Athola on Pipariya River.** Social Impact Assessment study was carried out by SIA Team of Gujarat Environment Management Institute (GEMI), Gandhinagar, Gujarat.

2. A total of NIL families are likely to be displaced due to the land acquisition. The Resident Deputy Collector (S) is appointed as Administrator for the purpose of Rehabilitation and Resettlement of the affected families.

3. Therefore, it is notified that for the above said project in the Athola village of Dadra and Nagar Haveli District a piece of land, whose detail description is as following, is under acquisition:

4. This notification is made under the provisions of Section-11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act no. 30/2013), to all whom it may concern.

5. A plan of the land may be inspected in the office of the District Collector, Dadra and Nagar Haveli, Silvassa and Resident Deputy Collector(Silvassa), Dadra and Nagar Haveli, Silvassa on any working day during the working hours.

6. The Government is pleased to authorize Survey and Settlement Officer and his staff to enter upon and survey land, take levels of any land, dig or bore into sub-soil & do all other acts required for the proper execution of their work as provided and specified in Section 12 of the said Act.

7. Under section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase, etc., or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.

8. Objections to the acquisition, if any, may be filed by the person interested within 60 (Sixty days) from the date of publication of this notification as provided under section 15 of the Act before District Collector.
