**ORDER**  
(u/s 144 Cr.PC)

**WHEREAS**, in the wake of outbreak of coronavirus (COVID-19), which is declared as a pandemic by the World Health Organisation, the Central Government had announced a 21 days of Total Lockdown from 25<sup>th</sup> March, 2020, so as to contain the spread of the said virus;

**AND WHEREAS**, this office had issued various orders to effectively carry out the said Lockdown as follows:

**THEREFORE**, in view of above and the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order that the above mentioned orders shall remain in force till 3<sup>rd</sup> May, 2020 11:59 p.m.

This Order shall come into force immediately from the date of issue and shall remain in force until 03<sup>rd</sup> May, 2020.

As the Order cannot be served individually, the Order is put in the public domain for information and necessary action.
