ORDER

WHEREAS, in the wake of Coronavirus (COVID-19), which is declared as pandemic by the World Health Organisation (WHO), the Central Government had ordered a total Lockdown throughout the country for 21 days from 25th March, 2020;

AND WHEREAS, due to increased number of cases of COVID-19, the Central Government has further extended the said Lockdown till 3rd May, 2020, so as to contain the spread and local transmission of the said virus;

AND WHEREAS, it is imperative to take precautionary steps towards the containment of the said virus;

THEREFORE, in view of above and in exercise of the powers conferred in Order No. 40-3/2020-DM-I(A) dtd. 15/04/2020 of Union Home Secretary, Ministry of Home Affairs, Govt. of India, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order that the following penalties shall be levied and collected from all persons and entities violating the directions issued by the District Administration.

Sr. No.	Action	Penalty (in Rs.)
01.	Person found without wearing mask in public places and work places.	100
02.	05 or more persons gathering in public spaces.	500
03.	Spitting in public spaces.	100
04.	Spitting gutka, tobacco, etc. in public spaces.	100

The above directions including imposition of penalties shall be enforced by Revenue Department, Police Department, Silvassa Municipal Council, District Panchayat, Gram Panchayat, Health Department, Labour Department, Excise Department, Education Department and Special Executive Magistrates.

This order shall come into force with immediate effect and shall remain in force till further orders.
