ORDER


WHEREAS, to prevent the spread of Corona virus and take precautions for preventing community level spreading, Order No. ADM/DM/COVID-19/355/2020/899 dated 06/04/2020 and Order No. ADM/DM/COVID-19/355/2020/901 dated 06/04/2020 were issued ordering that all shops for retail sale of groceries and other essential supplies would remain open from 8 am to 1 pm;

AND WHEREAS, UT Administration has issued an Order No. DMHS/COVID-19/2020/3461 dated 27/04/2020, wherein all shops shall remain operational between 8 am to 4 pm till further orders;

THEREFORE, in view of above and under the section 34 (m) of the Disaster Management Act 2005, it is hereby ordered that all shops in Dadra and Nagar Haveli except in the containment region shall remain open from **8 am to 4 pm** with immediate effect.

The pharmacies, hospital and other emergency services shall remain open during normal hours.

Bars, Gyms, Parlours, Saloons shall continue to be prohibited. Hotels, Restaurants are prohibited for dining, however restaurants can undertake takeaways orders and home delivery. Sale of liquor and other items continues to be prohibited as specified in the UT Directives of COVID-19 management.
