ORDER
(u/s 144 Cr.P.C.)

WHEREAS, in the wake of spread of Coronavirus (COVID-19), the Central Government under the direction of National Disaster Management Authority, had ordered a Total Lockdown of 21 days throughout the Country from 25th March, 2020, in order to contain the spread of the said coronavirus. Under further directions of NDMA, the Central Government further extended the said Lockdown till 03rd May, 2020;

AND WHEREAS, the Central Government has further extended the said Lockdown till 17th May, 2020, vide Order No. 40-3/2020-DM-I(A) dtd. 1st May, 2020, issued by the Union Home Secretary, Ministry of Home Affair, Govt. of India, with the directions to identify the districts of the Country into Green Zones, Red Zones or Hotspot Districts and Orange Zones and guidelines for operations in each of the said Zones;

AND WHEREAS, Dadra & Nagar Haveli falls under the **Green Zone** as there has been zero confirmed cases in the last 21 days as prescribed by the Ministry of Home Affairs vide Order dtd. 1st May, 2020;

THEREFORE, in conformity with the Order dtd. 01st May, 2020 issued by the MHA and in exercise of the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order as follows:

1. Assembly of 05 or more persons shall be prohibited.
2. No movement by any person shall between 04:00 p.m. to 08:00 a.m. except for medical emergencies and essential services emergencies.
3. All the directions issued by the Central Government of India vide Order No. 40-3/2020-DM-I(A) dtd. 1st May, 2020 and Order No. DMHS/COVID-19/2020/3672 dtd. 3rd May, 2020, issued by the Secretary (Health & Family Welfare), Dadra & Nagar Haveli and Daman & Diu, shall be strictly complied with by all the persons in the District.
4. All passes and permissions issued by the District Administration shall remain valid till **17th May, 2020.**

This Order is issued in supersession of all the previous Orders issued under section 144 of Code of Criminal Procedure, 1973, related to coronavirus (COVID-19)

This Order shall come into force immediately from the date of issue and shall remain in force till 17th May, 2020.

As this order cannot be served to all the persons, it has been put in the public domain for information of the public at large.
