ORDER

The Ministry of Home Affairs vide its Order No. 40-3/2020-DM-I(A) dtd. 20th May, 2020, lifted the prohibition of domestic air travel of passengers. To that effect, the Ministry of Civil Aviation vide its Order No. A.V.29017/5/2020-DT dtd. 21st May, 2020 issued guidelines to be followed by passengers; and Specific Operating Guidelines for major stakeholders (Airlines, Airport Operators, Ground Handling Agencies, etc.).

In order to operationalize the said guidelines, Standard Operating Procedure has been devised, which is marked and annexed to this Order as "ANNEXURE". All the concerned are requested to follow the said SOP in letter and spirit.

SOP for exit of persons having confirmed flight e-ticket

It has been noticed that certain people with confirmed flight e-tickets are wanting to exit the territory. In this regard, a SOP has been issued by Ministry of Civil Aviation vide its No. A.V.29017/5/2020-DT dtd. 21st May, 2020. Accordingly, the following directions are issued to ensure:

- (1) The movement of passengers having confirmed e-ticket shall be allowed without the need for any separate Order for the movement.
- (2) If any driver is going to drop such person and the driver intends to return back, however, he shall fill form 'A' as annexed to this SOP at the time of exit from the Checkpost. If the driver does not want to return back then he shall need an Order from the SDM/Incident Commander to exit the territory.
- (3) If the driver has filled Form 'A' for his return, in that case the driver shall be granted entry into Dadra and Nagar Haveli without the order of the SDM / Incident Commander if he returns within 12 hours of his exit from the territory.
