ORDER

WHEREAS, in the wake of spread of Coronavirus (COVID-19), the Ministry of Home Affairs vide its Order No. 40-3/2020-DM-I(A) dtd. 24th March, 2020, had ordered a Total Lockdown of 21 days throughout the Country from 25th March, 2020, in order to contain the spread of the said coronavirus;

AND WHEREAS, vide its subsequent orders of even number, the said Lockdown was extended from time to time till 31st July, 2020;

AND WHEREAS, the Ministry of Home Affairs vide its Order No. 40-3/2020-DM-I(A) dtd. 29th July, 2020, has extended the Lockdown only for the areas which are identified as Containment Zone in the Country upto 31st August, 2020 and has directed to re-open prohibited activities in a phased manner in areas outside Containment Zones;

NOW THEREFORE, in view of above and in exercise of the powers conferred under Section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order as under:

1. No fake news or rumors shall be spread by any person related to the Coronavirus (COVID-19);
2. Movement of individuals shall remain strictly prohibited between 10:00 p.m. to 05:00 a.m. except for medical emergencies and essential services emergencies;
3. All the shops in Dadra & Nagar Haveli shall be allowed to remain open from 05:00 a.m. to 10:00 p.m.;
4. All the directions issued by the Central Government of India vide Order No. 40-3/2020-DM-I(A) dtd. 29th July, 2020 and Order No. DMHS/COVID-19/2020/291 dtd. 31st July, 2020 issued by the Secretary (Health & Family Welfare), D&NH and D&D, shall be strictly complied with by all the persons.

This Order shall come into force immediately from the date of issue and shall remain in force till 31st August, 2020.

As this order cannot be served to all the persons, it has been put in the public domain for information of the public at large.
