ORDER

In pursuance of the above mentioned orders and the ongoing efforts towards the containment and prevention of spread of novel Coronavirus (COVID-19) in Dadra and Nagar Haveli, under the section 34 of Disaster Management Act, 2005, for the purpose of assisting and protecting the community, it is hereby ordered with immediate effect:-

1. All hotels, resorts, lodges, apartments, guest houses shall not accept any booking or allow any new guests with immediate effect and till 4th April 2020. No further booking shall be made without the prior permission of the District Collectorate, DNH. An email can be sent at collectordnh@gmail.com or dmc.dnh.ut@gmail.com.
2. All restaurants and eateries shall remain closed to prevent the assembly and gathering of people till 4th April 2020. However, home delivery services shall be allowed with ensuring the disinfecting of hands of the delivery person and the food items delivered. All cooking staff, vehicles, utensils, delivery case used in the process shall be sanitized and frequently disinfected. The Food and Safety Inspector, DNH shall ensure strict compliance of the same.

The Mamlatdar (Silvassa), Mamlatdar (Khanvel), Excise Inspector, DNH and The Food and Safety Inspector, DNH shall ensure strict compliance of the above.

There shall be no restriction on movement of people to buy their daily groceries and essential supplies. However, all individuals are advised to maintain personal hygiene and maintain social distancing as a precautionary measure.
