**ORDER**  
(u/s 144 Cr.P.C., 1973)

**WHEREAS**, the World Health Organization has declared COVID-19 as a pandemic and the number of positive cases as a whole in the Country as well as in the neighbouring States of the U.T. of Dadra & Nagar Haveli and Daman & Diu are increasing;

**AND WHEREAS**, it is expedient to take stringent measures in order to prevent and contain the spread of the COVID-19 virus in the UT of DNH and DD

**AND WHEREAS**, it is indispensable that social distancing be adopted for the containment of the spread of COVID-19;

**AND WHEREAS**, keeping in view the use of lifts / elevators for high-rise and multi-storeyed buildings may expose the users to the said virus, and thus, it is imperative to take necessary steps to contain the spread of the said virus through lifts / elevators in the said Buildings.


**THEREFORE**, in view of above and the powers conferred under section 144 of Code of Criminal Procedure Code, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order that.


1. All the lifts / elevators in the High-rise and Multi-storeyed Buildings shall be disinfected and sanitized every 02 (Two) Hours;
2. All the High-rise and Multi-storeyed Buildings shall also be disinfected and sanitized

This Order shall come into force immediately from the date of issue and shall remain in force until 31<sup>st</sup> March, 2020 till 11:59 p.m.

Chief Executive Officer, District Panchayat, D&NH, Chief Officer (Silvassa Municipal Council), D&NH and Member Secretary (DNHPDA), shall enforce the same in their jurisdiction
