ORDER
(under Disaster Management Act)

WHEREAS, in the wake of outbreak of coronavirus (COVID-19), World Health Organisation declared pandemic, and its proliferating rate of spreading, the Hon'ble Prime Minister of India has announced a Total Lockdown for 21 days from 25th March, 2020, in order to contain the spread of the said virus;

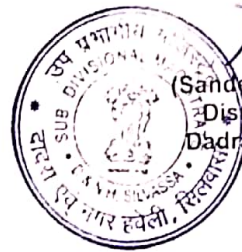
AND WHEREAS, the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu are taking necessary steps to effectively enforce the above mentioned directions by the Hon'ble Prime Minister of India, wherein the main focus is to minimize unnecessary movement of general public.

AND WHEREAS, and as per the Annexure to Ministry of Home Affairs Order No. 10-3/2020-DM-I(A) dtd. 24th March, 2020, issued by the Union Home Secretary, Govt. Of India, New Delhi, manufacturing units of essential commodities shall remain functional.

THEREFORE, in view of above and in exercise of the powers conferred under sub-section (m) of section 34 of the Disaster Management Act, 2005, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order that all the functioning industries ensure that the following steps are taken:

- (a) The industry shall be sanitized and disinfected every two hours;
- (b) The industry shall ensure that there is ample facilities for hand wash for all the workers;
- (c) The industry shall keep Thermal Scanner at all the entry points;
- (d) The industry shall ensure that the works are practicing social distancing while working; and
- (e) The industry shall provide Food and water to the workers working in the industry

The functioning industry shall comply with all the directions issued by the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu with regards to the coronavirus (COVID-19).
