ORDER

WHEREAS, in the wake of outbreak of coronavirus (COVID-19), which World Health Organisation declared pandemic, the Hon'ble Prime Minister of India has announced a Total Lockdown for 21 days from 25th March, 2020, in order to contain the spread of the said virus;

AND WHEREAS, the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu are taking necessary steps to effectively enforce the above mentioned directions by the Hon'ble Prime Minister of India, wherein the main focus is to minimize unnecessary movement of general public;

AND WHEREAS, a case of COVID-19 was reported residing in Naroli which, therefore, has been declared as epicenter for the outbreak of COVID-19 in Dadra and Nagar Haveli and the said case was not reported to the concerned Health Department;

AND WHEREAS, an order dated 06.04.2020 was issued u/s 144 of Cr.PC, 1973 stating that any person with Flu like symptoms shall report to the nearest health care facility such as Primary health Centre, Community Health Centre, Sub District Hospital and Shree Vinoba Bhave Civil Hospital, which shall then be intimated by Medical Officers of PHCs, Sub-District Hospitals, Shri VBCH/ District Hospital and Private Hospitals to the Director, Medical and Health Services for taking necessary action as per the Ministry of Health and Family Welfare guidelines;

THEREFORE, in view of above and the powers conferred under section 144 of Code of Criminal Procedure, 1973, I, Sandeep Kumar Singh, District Magistrate, Dadra & Nagar Haveli, hereby order that all the Chemist of Dadra and Nagar Haveli shall not sell any medicines for fever, cough or cold without proper prescription of the Medical Officer.

Any person found in contravention shall be punished under Section 188 of the Indian Penal Code.

This Order shall come into force immediately from the date of issue and shall remain in force for 60 days from issue of this order.
