(b) To grant New Excise License for manufacturing of Medicinal and Toilet Preparation containing Alcohol and Narcotics, Bonded Warehouse under Medicinal and Toilet Preparation Act, 1955 with Rules 1956. (c) To renew all kinds of Excise License. (d) To grant Import Permit, Release Permit, Issue of Verification Certificate for Receipt of Alcohol to the Licensees. (e) To Levy and Collection of Excise Duties and Tree Tax. (f) To Inspect, Investigate, Search and Seize, for Enforcing Excise Duty Rules and Regulation. (g) Patrolling of Illegal transportation of Liquor. (h) To Compound Offences on request.
