- I. The Vacancies referred to in clause (d) and (e) of sub-section 1 of section 6 shall be filled by nomination by the UT administration with the approval of the Chairperson.
- II. The term of office of the members other than those who are member's ex- office shall be for a period of **three years** from the date of issue of this notification.
- III. A Member of the state board other than ex-officio members, shall be entitled to receive traveling allowance and daily allowance at the rates admissible to Group A/ class I Officer, for the purpose of attending a meeting of the State Board of for the purpose of discharging any duty assigned to him by the State Board.
- IV. The Board shall meet at least twice a year at a decided with the approval of the Chairperson.
- V. The Board shall regulate its own procedure including the quorum.
- VI. The Chairperson may invite any person or persons having experience in Wild life management, conservation and allied fields to attend the meeting of the State Board.
